This has reference to your RTI application received in this office on 15.12.14. The replies against your queries are furnished below.

Query 1: Whether any compensation has been given to the land owner bearing survey No 8/B5 located at Sirsi taluk, Landakanalli (Uttar Kannada District), Karnataka as a Transmission tower has been laid down in the land for 400 kV line of Kaiga Power Station

Reply: No compensation has been given to the owner of land bearing Sy No 8/B5, Landakanahalli Village, Sirsi Taluk. It may be noted that during construction of any transmission line including installation of towers, no land is needed to be acquired. Further, as per law, there is no provision of giving compensation to any land owner on account of land utilized for erecting tower in their land.
