This has reference to your RTI application received in this office on 16.12.14 through our Mysore office wherein you had requested us to furnish relevant Act/Rule which had authorized POWERGRID officials to execute transmission line work without prior notice/ permission of the land owner. Reply to your query is furnished below:

Power Grid Corporation of India Ltd (POWERGRID) is a Government Company registered under the Companies Act, 1956 and a licensee engaged in the business of inter-State transmission of electricity under the Electricity Act, 2003. Invoking the powers conferred by Section 164 of the Electricity Act 2003, Ministry of Power, Government of India vide Extraordinary Gazette notification No 1148 dt 24<sup>th</sup> Dec 2003 has authorized POWERGRID to exercise all the powers vested in the Telegraph Authority under Part III of the Indian Telegraph Act 1885 with respect to the electrical lines established or to be established for the transmission of electricity. As per Clause 10, Part III of the Telegraph Act, powers have been conferred on the Telegraph Authority to place and maintain a telegraph line under, over, along, across or upon any immovable property. The above said powers of the Telegraph Authority has further

been extended to POWERGRID in placing and maintaining their electricity lines also vide the above mentioned Govt of India, Gazette Notification dt 24.12.2003. While placing the telegraph/electricity line, the Act do not warrant the Telegraph Authority/POWERGRID to take permission of any individual land owner except in respect of property vested under the control of local authority. POWERGRID is presently executing their transmission line work invoking relevant provisions of the said Telegraph Act.
