Point wise reply to the queries by Shri Raghavendra Venkaji Kulakarni, Todalabagi, Village, Bagalkot Dist.

Sl.No	Query	Reply
1.	How much area of land you have acquired?	During construction of any transmission line including installation of towers, no land is needed to be acquired. Accordingly no land under your possession will be acquired.
2.	How much compensation amount you are going to pay for the land acquired area?	Since no land is acquired, no land compensation is applicable.
3.	How much compensation amount you are going to pay for sugarcane grown up in my land acquired by you?	No land is acquired. However, based on the area of sugarcane damaged during any activity of construction of transmission line, Crop Clearance and Tree Compensation certificate mentioning the actual damage caused shall be issued after the execution of work and based on the above and on the yield of the crop assessed by Agriculture
		Dept., and at the rates fixed by Karnataka sugarcane control board, compensation shall be paid. In your case also, the compensation amount shall be paid as per the above method to the extent of damages. The actual compensation can be worked out only after assessing the actual damage caused.
4.	How much compensation amount you are going to pay for the damage of drip irrigation system implemented for sugarcane in the area which you have acquired?	Instead of payment of compensation for the damages of installations, if any, the damages shall be made good to the satisfaction of the owner.
5.	The area which you have acquired and within the line corridor, there are grown up teak wood trees, for which how much compensation are you going to pay per tree.	In exercise of the Powers under the Indian Telegraphic Act 1885, Part-III, section 10-19 conferred under section 164 of the Electricity Act-2003, notice shall be issued, for the damage that may be caused to the standing crops and the trees within the Right of Way, which are required to be cut/removed and the compensation for the same shall be paid as per the assessment of the State Revenue / Horticulture / Agriculture / Forest Dept.
6.	Provide a copy of detailed report regarding the assessment for the compensation of the land being damaged carried out by Revenue / Horticulture/Forest department.
