Sub: Your appeal against the information furnished by CPIO under RTI Act 2005

Dear Shri V.K.Gaur ,

This has reference to your 1st Appeal dt 23.03.2015 made under the RTI Act 2005 against the information furnished by the CPIO on 10.03.2015. On receiving your appeal, comments/opinion of the CPIO & other related departments were taken and relevant papers were perused. It may be noted that under the RTI Act, appeal against the sufficiency of information provided by the CPIO in a particular RTI application shall be considered only in the context of the information sought in the original application. Any additional details or information sought/furnished in the appeal stage shall not be considered while disposing the appeal.

It is seen that information had been sought by you from CPIO vide your RTI application dt 09.02.2015 regarding the action taken on your an earlier letter dt. 27.05.2013 addressed to Chief Manager/HR, POWERGRID, SRTS-II. On going through the records, it is observed that three queries were specifically raised in your letter dt 27.05.2013 and action taken on each of them were furnished by CPIO in his RTI reply dated 10.03.2015, as per the following details:

Query No. 1: Non-payment of HRA of Rs 47,625/-

In your letter dt 27.05.2013, you had not clearly mentioned the details of period for which the above said amount of HRA has been deducted. As your query was not period specific, CPIO had been right in providing the reply as stated in his RTI reply dt 10.03.2015.

Query No. 2: Release of adjusted salary for the period from 27.02.2007 to 31.03.2007

The payment for the period from 27.02.2007 to 31.03.2007 was already made and communications from NRTS-I confirming the release of the payment along with related salary slip were furnished to you by CPIO in his reply dated 10.03.2015.

Query No. 3: Salary payment for the period from 24.05.2006 to 26.02.2007

NRTS-I HR Department had advised you to submit an un-conditional undertaking regarding salary payment for the period from 24.05.2006 to 26.02.2007. Copy of this letter addressed to you was enclosed by CPIO along with his RTI reply.

As seen above, the information sought by you vide your RTI application dt 09.02.2015 have already been furnished by the CPIO.

The appeal is accordingly disposed off.
