Qua the information furnished by the CPIO/DGM, POWERGRID, SR-II vide his letter Ref: SR-II: RTI:F-303:2015/38236 dated 10/03/2015 which has been received on dated-13/03./2015.

Sir,

With respect to the above mentioned information supplied by CPIO/DGM Power Grid Corporation of India Ltd, it is submitted at the threshold that the furnished information is fabricated, concocted and misleading. The information provided by the CPIO/DGM is tangentially deviating from the main issue. The CPIO/DGM has concealed the necessary information and has tried to put the appellant under dark as some of the answers to the queries are doubtful. The grounds of appeal, point wise, are being furnished in the below mentioned paras.

Query No. 1:- With regard to this query, the CPIO/DGM has not supplied proper and adequate information. The information supplied to this query is misleading. It is submitted that is view of the pay revision circular No.277/2010 dated 23/10/2010, all financial benefits are liable to the period w.e.f. 26.11.2008. However, the PGCIL disbursed HRA arrear from 26.11.2008 to 30.09.2010 and further HRA worth Rs-1051/- for the month of March, 2011 to the undersigned. Rs-1051/- as HRA is too less. It is further submitted that the PGCIL deducted Rs- 15875*3 = Rs-47625/- from the salary of the undersigned for the month November 2011, December 2011 and January 2012. Those figures are as per undersigned of salary slip of the respective months by the undersigned. The CPIO/DGM has tried to put curtain on these facts.

Query No. 2:- With regards to furnishing information against this query, (a) it is submitted that there is nothing to show that payment was made to the undersigned as the pay revision circular No. 277/2010 dated 23.10.2010 as mentioned in letter dated 03.09.2010. It is highly unbelievable as to how the further revised salary was adjusted in past i.e. from the period 27.02.2007 to 31.03.2007. Thus the information furnished by the CPIO/DGM is misleading.

(b) This information is misleading and illegal. It is submitted that as per the order of Hon'ble High Court (DB) in LPA No. 1793/2006 dated 01.09.2006, the <u>Status Quo as regards order dated 23.05.2006 was maintain and on that date undersigned was on duty</u>. Therefore it was not proper for the PGCIL to bifurcate the periods such as 24.05.2005 to 31.08.2006 on leave, and 01.09.2006 to 26.02.2007 on

actual duty. I am not under any compulsion to give an undertaking as per the desire of the PGCIL which is contrary to the aforesaid order of Hon'ble Delhi High Court.

(c) The information furnished by the CPIO/DGM is illegal and misleading. It is beyond comprehension as to how the arrear of the revised salary in view of pay revision circular No.277/2010 dated23.10.2010 was adjusted in past.

Query No. 3:- The information supplied against this query is misleading and deviating from the main issue. The objection raised in point (b) above may kindly be read as part and parcel of this ground above as the same are not repeated herein for sake of brevity.

INFORMATION NOT SUPPLIED: Why the sum pertain to Leave without Pay (LWP) was deducted from the arrear of salary of the undersigned, when the undersigned has never been on LWP throughout his service with the PGCIL. It may be noted that PGCIL has illegally deducted Rs-51827/- from the arrear of salary of the undersigned. The PGCIL has illegally deducted the Half Pay Leave (HPL) from arrear payable to the undersigned. These are 09 HPLs, 03 HPL- in April 2007, 01 HPL- in August 2008 and 05 HPL- in October 2008 for which the HPLs have been deducted by the PGCIL illegally.

Kindly furnish the desired information to the undersigned at the earliest and take necessary action against the CPIO/DGM for giving misleading information to the undersigned.
