Sir,

This has reference to your RTI application received in this office on 24.04.2015. In this regard, it is to inform you that compensation of Rs. 86,982/- was paid to you as mandated by GO (Rt.)No.581/2010/RD dated 04/02/10 for 2.071 ares land considering the fair value of the land as Rs. 60,000/- per are. Vide court order on WP (C) 9158/12, the fair value of this property was changed to Rs. 75,000/- per are making the payable amount of Rs.1,08,728/- in line with GO (Rt.)No. 581/2010/RD dated 04/02/10, the additional amount involved being Rs.21,746/-. This calculation was made by LA authorities and approved by Dist. Collector, Ernakulam with case no.LV-23/11/KT.

GO (Rt.)No. 581/2010/RD dated 04/02/10 was challenged by POWERGRID through WP(C) No. 22382 dated 06/09/2013. In the verdict dated 28/05/14 on this petition, GO (Rt.)No. 581/2010/RD dated 04/02/10 was not upheld by the court and it is no more mandatory on the part of POWERGRID to make payments necessitated only due to this GO, like in the instant case. Hence Rs. 21,746/- is not required to be paid and not paid.

If the copy of the above said court order is required then you are requested to remit a payment of **Rs 50.00**(Rs.2.0 per page x 25 pages) towards charges for photocopying (in the form of cash/ IPO/ demand draft /banker's cheque in favour of Power Grid Corporation of India Ltd payable at Bangalore).
