This has reference to your RTI application received in this office on 12.05.2015 through our Corporate Office. The information sought under RTI pertaining to Southern Region Transmission System – II are furnished below:

Query: The complete detail of positions identified along with the eligibility criterion and emoluments for differently abled people under Chapter-VI-para 32 of People with Disabilities act, 1995.

Reply: In POWERGRID SRTS-II for identification of posts suitable for different subcategories of PwD, the identification done and notified by Ministry of Social Justice and Empowerment is followed.

The emoluments and eligibility criteria for different posts are as per the existing policies and are published in respective advertisements. Emoluments offered to candidates selected against reserved posts are same as that offered to those who are selected against unreserved posts.

However, the eligibility criteria are relaxed for PwD candidates as mentioned below:

• Age: Relaxation as per clause 21 of DoPT OM No. 36035/3/2004-Estt.(Res.) dated 29.12.2005 irrespective of reservation for posts for PwD.

 Marks in essential qualification: Relaxation at par with SC/ST candidates subject to reservation of posts.

No. of years of experience: Relaxation at par with SC/ST candidates subject to reservation of posts.
