# <u>Point wise reply to RTI Query by Smt.Sridevi Prasad,Bangalore (On line RTI Request Registration No.PGCIL/R/2015/60074 dated 13.06.2015)</u>

#### Query no.1:

Please provide me with copy of notice sent to me before drawing and erecting high power lines in Sy. No/Khata No. 55/119, situated in Bheemenahalli in Manchanayakanahalli Panchayat of Bidadi Hobli, Ramanagara District, Karnataka?

#### Reply:

No notice was issued in respect of survey number 55/119 to Smt Sridevi Prasad before construction of 400kV multi circuit line in Bheemenahalli village as per available records.

#### Query no.2:

Details of Compensation paid to the land owners in the above said survey number on whose land / site power lines are drawn?

**Reply**: No compensation is paid to any land owner with survey number 55/119.

#### Query No.3:

Why compensation is not paid to me after you have erected tower adjoining my site in the said Sy. No. 55/119 (Pisa Layout) and drawing power line over it?

#### Reply:

There was no standing tree or cultivated crop in your land and hence no crop compensation or tree compensation was payable to you.

Compensation for land damage along the line route was paid only in specific cases under the orders of Deputy Commissioner, Ramanagara. Your name as well as the survey number stated by you was not available in the details of land damage along the transmission line route communicated by Tahsildar, Ramanagara.

#### Query No.4:

Why you have not followed up with concerned authorities as mentioned in your letter reference No: SR-II / S'halli / Bidadi Lilo / L-Compensation dated 01/09/2014 signed by Sr. Engineer/TLM Somanahalli

#### Reply:

On receipt of your letter, your case was referred to Tahsildar, Ramanagara vide our letter No: SR-II/ S'halli/ Bidadi LILO/L-Compensation dated 10/09/2014 by Chief Manager Somanahalli, with a request to identify the extent of land affected and amount of compensation payable to you. However, no reply was received from the Tahsildar.

#### Query No. 5:

When are you paying me the compensation?

#### Reply:

The question is seeking information on time estimate for a future action. No such records are available.
