SUB : HANDING OVER OF KEYS

Sir,

I am in receipt of your registered post letter No. NR1/MND/HRM/497 dated 03.09.2007 which has been received by me on 14.09.2007 at 2.35 P.M.

Before I submit my reply I would like to invite your kind attention to your office letter No. NR1/MND/HRM/Conf./562 dated 26-27.10.2006 and its information by way of telephone was communicated to Sh. Rajiv Mohan, DGM Mandola, stating that the status-quo was granted on 01.09.2006 and in accordance to that I requested to give me in writing or through Hon'ble Court, so that the keys may be handed over. I don't have any feeling of disobedience, it was merely a technical ground due to which I requested for the same.

Now, in the present letter I have been again asked to hand over the keys of official, tables/files cabinets/Almirahs etc. to HR Department, Mandola at the earliest. In this respect, I bring the following facts to your notice : -

- I. Presently, I am posted at Bheenmal (Jalor), Rajasthan and till I am not relieved officially for the said purpose. It will be disobedient to the management, if I proceed without relieving. Hence you are requested to instruct the incharge of the present posting station to relieve me officially for the said purpose.
- II. It would have been better if the same instructions should have been conveyed to me before relieving from the previous posting of place.
- III. It is also not understood, what was the hurry to relieve me on fax message without handing over the charge to the HR Department Mandola.
- IV. Had it been adopted this procedure at the right time and official charges for which now I am eligible should have been avoided ?
- V. In my opinion, this is lack in coordination and not proper decision at the right time.

In the light of the above, I therefore, request to please instruct to the incharge of present posting station to relieve me officially, so that I may comply your instructions and hand over the charge to the person to whom I am directed.
