## Point wise reply to the RTI queries from Sh.Balasubramaniyan

Query no.1: What is the horizontal clearance applicable to the inhabited house and the shortest conductor in the line?

**Reply:** Central Electricity Authority, Safety Regulations, 2010 specifies the clearances to be maintained from a building whenever an overhead line passes above or adjacent to any building. As per clause 61 of the above regulations, the clearance required for a transmission line is as follows:

- 1) Horizontal clearance from the building on the basis of maximum deflection of the conductor
- 3.7 meters plus 0.30 meter for every additional 33kV or part thereof.
- 2) Vertical clearance from the building on the basis of maximum sag of the conductor

} 2.0 meters plus 0.3 meter for }every additional 33Kv or part }thereof.

Accordingly, a horizontal clearance of 10.6 m / vertical clearance of 8.9 m, as applicable, is required to be maintained from a 765 kV transmission line.

Query no.2: What is the horizontal clearance for other objects (such as trees)?

**Reply**: 33.5 meter on each side from centre of the tower.

Query No.3: What is the compensation rate for the trees to be cut which is coming under the clearance area?

**Reply**: The compensation rate for trees will be given based on the Inspection/assessment of values by the respective Agriculture/Horticulture/Forest department officials of respective Districts of Govt. of Tamil Nadu.

Query No.4: We won't be able to cultivate any crops in our land due to this and how to sought compensation for this.

Reply :All type of crops can be cultivated under transmission line. No compensation can be sought for the land, since no land was acquired for the construction of Transmission Line as per government norms.
