Reply to Query No.1 :

POWERGRID has established Madhugiri Substation on the basis of approval from Ministry of Power, Govt of India vide their Letter No.11/4/2007-PG dt.03.12.2009

Copy of the same can be furnished on payment of Rs.2/- as photo copying charges.

Reply to Query No.2:

The following POWERGRID transmission lines are emanating from the Substation.

- a) Gooty - Madhugiri 400kV D/C line
- b) Madhugiri – Yelahanka 400kV D/C line
- c) Madhugiri – Salem 765kV S/C line-I
- d) Madhugiri – Salem 765kV S/C line – II

Copy of approvals for formation of the above lines consists of 3 pages and the same can be furnished on payment of Rs.6/- as photo copying charges

Reply to Query No.3

As per the rules in vogue, no consent is required from farmers and village meetings are not necessary for establishing Transmission lines. However, the Deputy Commissioner, Tumkur had taken several meetings with Raitha Sangha representatives and POWERGRID officials and had fixed the compensation package.

Copy of the order from the DC/Tumkur consisting of 2 pages can be furnished on payment of Rs.4/- as photo copying charges.

Reply to Query No.4

The contract for construction of substation was awarded to M/s. EMC at a cost of Rs 59 crores.
