Reply to Q.No.2: After cutting of the trees in full against the referred Notice No. 1978, the amount of Rs. 5,72,871/- as approved by Horticulture dept/Shenkottah/Tirunelveli was paid to the land owner in presence of Revenue personnel/Shenkottah on 11.01.2017 vide DD No. 016618 dated 07.01.2017.

Reply to Q.No.4: Likewise, against the other referred Notice No. 1957, the amount of Rs. 1,66,621/- as approved by Horticulture Dept/Shenkottah/Tirunelveli was paid to the land owner on 24.05.2011 vide DD No. 655124 dated 03.05.2011. As this was settled fully, action was not required to be taken.

Reply to Q.No.5: Since the payments as approved by the Horticulture Department were paid to the land owner after cutting of the tress in full, the question of belated payment does not arise.
