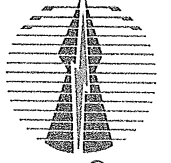

Pointwise information sought in your application for the Sy.No.76/1 (Patta No.166) of Thattimanapalli Village, Gudiyattam Taluk, Vellore District is furnished below:


1. An amount of Rs.2,75,250/- has been paid to the land owner as per the assessment of Agriculture/Horticulture/Forest Departments of Tamil Nadu. While processing the balance amount of compensation, objection raised by the landowner's brother and hence release of amount is kept pending.
2. No red gram, thuvaram plant is available in the above land. The teak wood and Alinchi wood would be cut after assessment by the Forest Department.
3. Compensation for the land as per the G.O.(MS) No.63 dated 22/11/2017 is 85% of land value determined by the District Magistrate for tower footing and 15% for corridor based on circle rate/guide line rates.

As per section 19 of the Right to Information Act 2005, if required, you may file an appeal to the First Appellate Authority of the organisation within 30 days of the issue of this order. The address of the First Appellate Authority is given below:
