I, Radhika, W/O Mr. V. Anand, Manager (F&A) S/O Late Vadivelu, working in Power Grid Corporation, Employee No. 01145 RHQ Bengaluru (PAN No. AFKPA3478H), would like to submit with great concern that myself and son Mahesh were subjected to torture and domestic violence physically, mentally, psychologically and financially by my husband since our marriage on dated 03.09.2004 and birth of our disabled child on 06.08.2005 (disabled on account of cerebral palsy with spastic diplegia) and ultimately were thrown out of the matrimonial house by him as he is not at all willing and ready to accept the responsibilities as dutiful father and husband on account of the disability of our son with Cerebral Palsy with spastic diplegia. As we could not tolerate the inhuman behaviour of my husband Mr. Anand, we filed a petition vide Crl. Misc. no. 330/2016 on 01.09.2016 before the Honourable Principal Family Court Judge at Bengaluru and the same was referred to mediation. A memorandum of settlement was reached and agreed between us on 16.12.2016 and even after this he miserably violated the settlement by not allowing me and son in the matrimonial house, not making arrangements for the education of our Child and also not making arrangements for the Ayurvedic treatment of son Mahesh who is suffering from Cerebral Palsy with spastic diplegia. In view of the arrogant and consistent inhuman behaviour of my husband who is always being misguided by his brother & his wife, we decided to seek the justice again and accordingly a petition was filed vide MC/1/2018 dated 04.01.2018 with the next hearing date 06.02.2018 before the Judicial Magistrate Judge at Poonamallee seeking the maintenance charges for running the family, education and treatment of our disabled child. The aforesaid petition was not received by him, rather might have been refused by him.

In view of the circumstances as stated above, I submit to request the following details in order to proceed with the case.

1. Salary details / Pay slip & Source of income declared by him and certified copies of ITRs filed by him for the years from 2014 _2015 to 2016 2017.

2. The exact place of posting of my husband in Power Grid Corporation of India Limited and his address to enable us to send the petition again from Poonamallee Judicial Magistrate Court vide Case no. 
