In your above letter it is learned that the Corridor of 400 K. V line is 46 mtrs.

Kindly clarify the utilisation of corridor of 400 K .V Line 46 mtrs.

It is understood that you are insisting to cut the trees from the entire width of 46 mtrs of corridor and compensation is eligible only for a width of 16 mtrs

Since the trees of 46 mtrs Corridor are cutting, and the victims are losing all kind of future yielding from big trees, it is requested to furnish the reason of restricting compensation only for 16 mtrs width, instead of giving compensation for 46 mtrs, and the 46 mtrs being utilised also.

It is understood that Power grid is giving value of trees which is cutting from the 46 mtrs Corridor. But in future victims cannot cultivate yielding non yielding big trees in the place of lost trees. Need a clarification on why Power Grid will not be giving compensation for the entire land within 46 mtrs Corridor.
