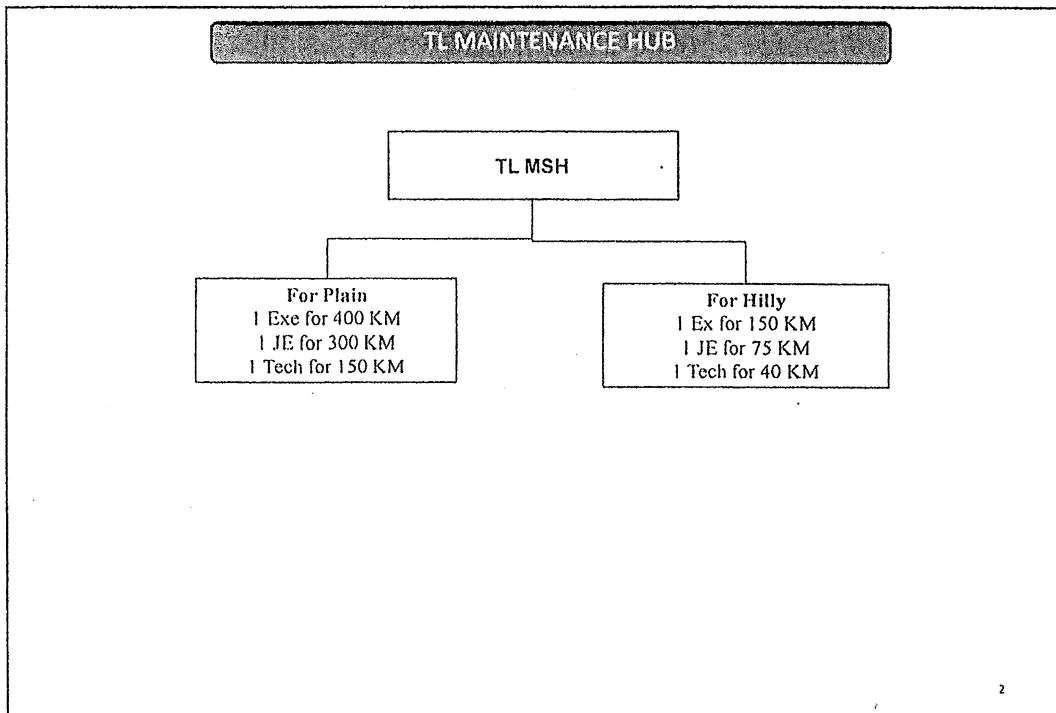
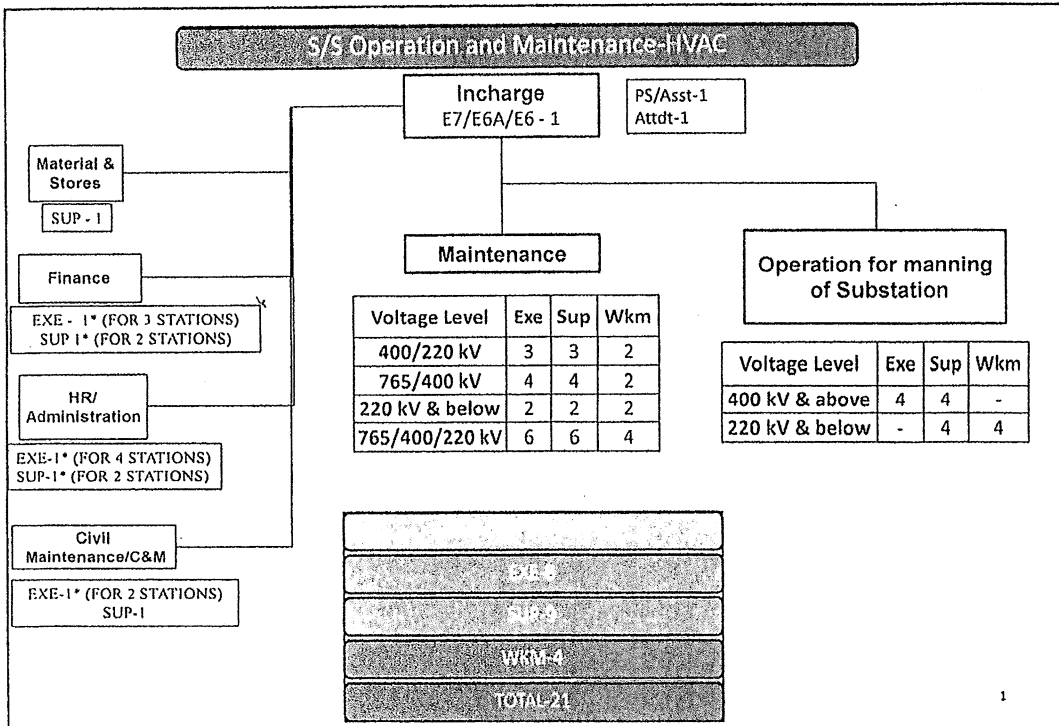

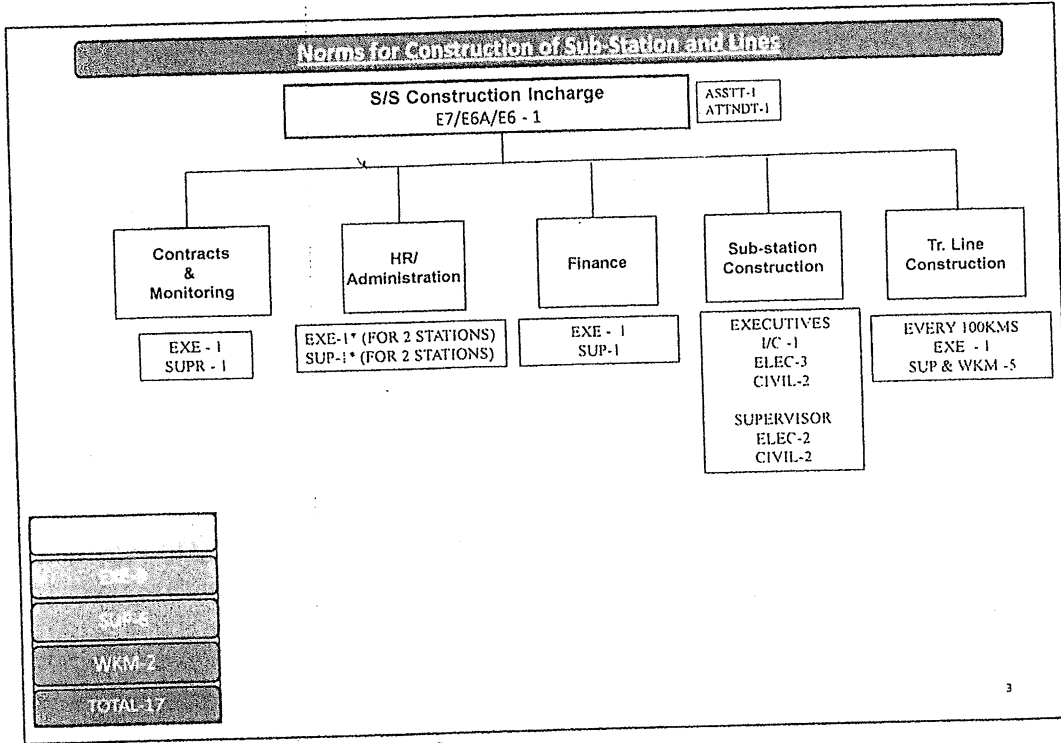

Sir

I have received only partial informations for the above mentioned RTI and the details of the incomplete answers are mentioning here for your kind information and necessary action.

- 1) For question no (a) there is no authorized signatures in annexure and also not duly signed by the CPIO.
- 2) For question no (b) the answer given is irrelevant and a misleading one from the questions asked. The question was "Is the above areas in SR2 are fully filled in line with the answer of question no a? If not fulfilled, Please provide the man power requirement rose from various areas and projects of SRTS-II".
- 3) For question no (c), the answer for the second portion is not given by the CPIO.
- 4) For question no (d), the answer for the second portion is not given by the CPIO.
- 5) For question no (e), (f) and (g) was not answered by the CPIO.
- 6) For question no (h) the administrative reason was not clearly specified by the CPIO.
- 7) For question no (k), the second portion was not answered by the CPIO and not furnished any details for the same.
- 8) Question no (l) was not answered by the CPIO.
- 9) For question (m), the copy of approvals not submitted by the CPIO.
- 10) Even though all data's are available in POWERGRID, CPIO replied it as "not available in SR2" which is a part of POWERGRID only and not a separate department.

Due to the above-mentioned issues from SI no 1 to 9, I am not satisfied with the reply of the POWERGRID CPIO and it is requesting you to provide the full information for my RTI dtd.02.08.2018. The copy of the RTI request and the reply received from your CPIO is enclosed for kind reference.
