1	The total number of workers engaged in the construction work and their cooly/wages paid	The work is executed on contract basis and hence there is no specific reference of number of labourers to be engaged and wages are made on the basis of work completed. Not on labour basis.
2	Total number of days they worked to construction and maintenance of the above work	LOA Contract completion date is 31/12/2018; <i>It is a work contract</i>
3	Total number of logs purchased/used and its value for using fencing purpose.	Waste wood available in the station is used. Nothing has been purchased.
4	Total number of iron barrier purchased for fencing purpose and its total value.	Iron grills/barriers are being provided as per item in Sl.No.13: "steel work welded in built up sections/famed work, including cutting, hoisting, fixing in position and applying a priming coat of approved steel primer using structural steel etc., as required in grating, frames, guard bar, ladder, railing, brackets, gages and similar works" of LOA SR-II/C&M/WC-1673/LOA-1764/2018/160 dated 17/04/2018 to M/s.Samy Construction, salem. As per LOA, the quantity of 3500 Kg at a total cost of Rs.2,97,500/- (excluding GST) is meant for supply and installation. The work is incomplete due to obstructions being done by the Luggage Tempo Drivers.
5	The total amount of expenditure incurred so far to construct and maintenance of road side park work (inlcuding contractor payments).	Around Rs.17940/- spent for purchase of 598 flowering plants. Till now billing has not been done to the contractor for grillwork, since the work is yet to be completed due to obstruction by local tempo drivers.

- 5 . The total amount of expenditure incurred sofar to construct and maintenance of Road Side Park work.(Including contractor payments).

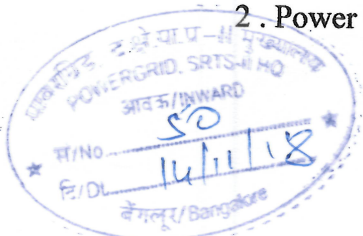
