In this regard, kind attention is drawn to the following RTI provisions:


**Quote from Chapter II page 5, RTI Act 2005**

Sirs,

We state that, we and our sisters namely Late. A.Senthamizh Selvi and A.Aramvazhi, and our only brother A.Arivithazh are the absolute owners of the scheduled mentioned property situated in S.No.123/1 and 123/2, S.No.128/2 of Ambalur Village, and we and above said persons has been in absolute occupation, possession and enjoyment of the same till this date as absolute owners since the schedule property was the absolute our father Late.A.S. Arjuna Gounder who died intestate leaving behind us and above named persons are his legal heirs. After the death of above Arjuna Gounder we and above said persons are in absolute possession and enjoyment of same till this date.

2. We state that, after the life time of our father Late.A.S.Arjuna Gounder the brother of us A.Arivithazh gave such troubles to us and refused to give yields from the schedule mentioned property for that we demanded partition of the schedule mentioned

properties and some other properties. But the above said A.Arivithazh refused to partition the property and gave one such share each of us. For that we filed a partition suit in O.S.No.143 of 2015 before the Hon'ble Subordinate Judge, Vaniyambadi which is still pending for adjudication.

3. We further states that, the Power Grid Corporation of India Limited have been entrusted by the Government of India for the construction of Power Grid Corporation of India Limited "± 800KV HVDC Raigagh- Pugalur Transmission Line Part -IX Associated with HVDC Bi-Pole Link between western region and Southern region. The said Project will pass through our un divided property as per your department intimation.

4. We state that, We planted Palms Trees in the year 1993, in the scheduled mentioned property as detailed below. The above said saplings are grownup as Trees upto 25 feet height, The Total value of the said trees are 50 Lakhs and above as per Government Forest Department Value.

5. We further state that, the value of the trees removed by your department is worth more than 50 lakhs

We therefore called upon you to provide information 1. Award passed by your department for payment of compensation. 2. As well as payment of 100% Solatium Amount of damages caused by you department to the schedule mentioned property so as to adjudicate the partition suit between ourselves and above said persons in O.S.No.143 of 2015 on the file of Hon'ble Subordinate Judge, Vaniyambadi, Vellore District, Tamil Nadu. 3. To whom the above compensation was given by your department. 4.The actual amount of compensation paid for the schedule mentioned property. 5.The number of trees cut down by you department in the schedule mentioned property. 6.The copy of the documents submitted by the person who received the compensation claiming the ownership of the schedule mentioned property. 7.The date of payment of compensation 8.The mode of payment of compensation.
