But the RTI is rejected on 07.08.2019 by CPIO saying that, Information can be provided only on clear, precise and specific queries. So I filed a fresh RTI Regn No: - PGCIL/R/2019/50362 dated 15.08.2019. So please Direct CPIO to provide me the information which I requested in my RTI Petition no: - PGCIL/R/2019/50362 dated 15.08.2019. I request you to kindly provide the above Information sought in English Language, as I hail from the State of Tamil Nadu. And I also request you to kindly provide me with the certified copy of the above details.
