Submitting appeal due to the following reasons:

1. Query No.2: Since there is no provision to apply region wise in online RTI, kindly provide the requested data.

Reply: SR- II is being requested to provide AAR rating for the year 2017 of the employee.

2. Query No.3: Since there is no provision to apply region wise in online RTI, kindly provide the requested data.

Reply: SR- II is being requested to provide AAR rating for all the years of the employee.

3. Query No.4: Since the DPC findings of my interview is an evaluation sheet kindly provided as requested.

Reply: DPC findings are contained in evaluation sheet. The Evaluation Sheet contains details of other candidates (3rd Party). Disclosure of such information is exempted under section 8(1) (j) of the Act. Further, the above information is also exempt as per clause 8 (1) (e) of the RTI Act as the above information is available with us in fiduciary capacity.

4. Query No.5 : Even though requested to provide the evaluated answer sheet without questions, the same was not provided. Also atleast the marks scored in detail also not provided.
