2. Our RTI application dated : 01.07.2019 to Executive Director(SRTS-II).

With reference to the above mentioned subject, we would like to bring to your kind notice that, we have not received proper information along with supporting documents for our RTI application queries dated: 01.07.2019.

1. In our RTI query No: 1 Total amount paid as compensation to farmers in Bangalore Urban District. Not provided the supporting Documents.
2. In RTI query No: 2 The Land market value is less than the Government value.
3. In RTI query No: 5 Case No and Court details not provided.
4. In RTI query No: 6 False information provided by the officials stating that line is not passing through Survey No. 72. The line is passing through Survey No. 72 as per revised plan and your officials have provided the Survey Sketch copies for Survey No.72 and 75. In Survey No.75 for foundation work utilized land is 4.71 Guntas and Line Corridor land utilized 01-31.79, altogether 01-36.50 Acre. But in RTI replay mention that 71.79 Guntas utilized for line Corridor.

5. In RTI query No: 7 Your officials have given false information stating that 'I have refused to accept the payment the same was not paid'. Mr. Bhima Shankar has shown a Cheque with name mistake and he is in confusion that how much land is using for foundation work and line Corridor work and also he told that, he will prepare a revised Survey Sketch for Survey No. 72 and 75. Till date he has not provided the Sketches of Survey No.72 and 75. Your office officials have violated the DC Order dated 18-05-2017 .**'It is clearly mentioned that the compensation amount should transfer to the concerned owner of the land / Farmers/ Account holders bank account by RTGS or through Cheque and confirm that transfer of amount, there after M/S.PGCIL to start the tower foundation work and line corridor work'**.
Moreover, in DC order dated 18-05-2017 my Land Survey No.72 is not mentioned due to no proper information has been provided to the DC office. Please refer your office letter dated 23-02-2018.

Therefore, we are herewith filing this appeal before the First Appellate Authority as per the Section 19 of the Right to Information Act 2005 to provide the proper information along with all necessary annexures of the Power Grid Project.
