Sir,

My house is located in a space between tower location nos 52 and 53 of Kylm- Edamon 220 KV power line. It has adequate clearence from the power line conductor as per CEA Regulation. 61 (3) (iii). I am living in the said house with my wife, 8 year old daughter and a 5year old son who is deaf and blind. As my son needs costly medicines, hearing aids and other medical assistance and I have meagre income, I have to go for Central and State government aids. For applying for these benifits one need to have a permanant building number and for that I have been running from pillar to post for sometime.

For this purpose I had been in constant touch with Power grid Corporation Office, Pathanamthitta. On a routine visit, one Viswambharan Asst. Engineer of Pathanamthitta Office has particularly inspected the site and on being convinced of the clearence inforemed the local body Office (Thekkeekkara grama Panchath) over phone that the PGC has no objection in allocating a permanant building number . But on the insistance of the local body on a written clearence certificate I have again approached the Pathanamthitta office and they have informed that they are not competent enough to issue the Clearence Certificate/Noc. I was also surprised to know that Pathanamthitta Office is unable to tell me as which Office of the PGC of India Ltd has competency to issue the NOC . So I had to put in an RTI application to the Pathanamthitta Office. Shokingly instead of forwarding my application by the Pathanamthitta Office to the concerned Office becuase of the incompetency as per the section 6(3) of the RTI act , the application was returned in an indiffernt manner . As per the direction contained in the returned RTI application , I have approched the DGM & CPIO yelahnka Hobli, Bangalore. As per the instruction to the last letter of protracted correspondence I am now preferring this appeal for your kind consideration and needful steps for the supply of the postal address of authority competetant for issue of clearence certificate/NOC at the earliast. Copies of the correspondence cited are enclosed herwith.

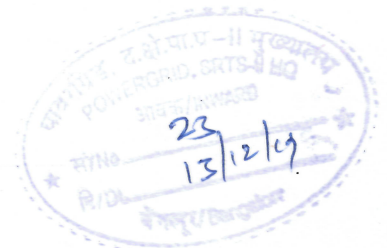
