

1 & 2. POWERGRID has only USER RIGHT and no acquisition of land is involved in laying of its transmission line or tower, as provided under the Indian Telegraph Act, 1885. Prior consent or prior permission is not stipulated in the Electricity Act, 2003 or in Indian Telegraph Act, 1885 and the same has been upheld by various Hight Courts and Supreme Court of India.

3. Compensation are being paid for the damages caused to the standing crops/ trees during the construction activity as per the assessment of the concerned department of State government officials of Horticulture/Agriculture/Forest). The Land compensation towards tower base area and RoW corridor shall be paid as per the orders of the District Collector concerned in reference to the TN GO Ms.no.86 dt 30.10.2019.

4 The size of tower base area varies depends on type of tower adopted as per the technical requirement. Based on the same, compensation will be paid.

5 Compensation payments are being paid for the damages caused to the standing crop/tree during construction activity viz. foundation, Tower erection, Stringing activity.

6 The compensation amount are being released / will be released through online Payment directly to the bank account of the concerned land owners.

7 Compensation are being paid for the damages caused to the standing crops/ trees during the construction activity as per the assessment of the concerned department of State government officials of Horticulture/Agriculture/Forest. The Land compensation towards tower base area and RoW corridor shall be paid as per the orders of the District Collector concerned in reference to the TN GO Ms.no.86 dt 30.10.2019.
