Applicant is Advocate to Sh.G.Venkatesan who is the owner of the land bearing S.F.No.294/2,294/3,294/4 in Ulagankattan village, Kallakurichi Taluk & District is existing in the line corridor of span T151/4 and T.151/5 of 400 kV D/C Pugalur-Thiruvalam TL (TW-04).

Q.No.	Reply
01, 02 & 03	The Techno-economically feasible Route has been finalised and approved by the Competent Authority concerned approving authority and it is being implemented. The information sought by the petitioner is technical documents and need not be shared, particularly in view of the fact that the Hon'ble High Court of Madras has perused the records & was satisfied and the procedure adopted by POWERGRID with regard to laying of Transmission Lines/ Towers has been recorded in its Order in W.A. No. 79 of 2019, with the finding that there is no malice in law or in facts and POWERGRID is performing its Statutory duty and the same has been confirmed by the Hon'ble Supreme Court of India.
04	No other POWERGRID Transmission Line is passing near to the land.
05, 07 & 09	Required clearance as specified in the Central Electricity Authority (Measures relating to Safety and Electric supply), Regulation, 2010 are being adhered to by POWERGRID and shall be adhered to by the concerned landowners.
06	Approximately 15 mtr. Height
08	Compensation will be paid based on the assessment, valuation by the concerned Agriculture/Horticulture/Forest and Revenue Departments of Government of Tamil Nadu.
