I humbly submit that myself and my brother A.Sampath were owning agricultural lands 4-63-0 Hectors in Elayanallur village, Katpadi Taluk, Vellore Dt, Tamil Nadu.

Our fertile agricultural lands 4-63-0 Hectors were acquired for Power Grid Corporation of India to establish Sub Station in Elaya nallur village, Katpadi Taluk, Vellore District, T.N. The Collector awarded very meagre compensation of Rs.56,800/- per Acre, in the year 2011. But Land Acquisition court, Vellore enhanced compensation at the rate of Rs.5,00,000/- per Acre with solatium and other benefits in L.A.O.P.1/2018 dated 08/08/2019/-. Till 21/07/2020 you have to pay additional compensation amount of Rs.1,68,70,272/- to us as per court judgment. You have not paid the additional compensation amount, not filed any appeal till this date.

2.We are agriculturists, we have no income, and we are suffering lot even for our livelihood. We have no other way except commit suicide. You did not care to deposit the said amount, nor preferred any appeal. Hence we have to filed Execution proceedings in Court and attach your office furniture, computes, and other movable properties and Bank Accounts. So we require the further details of your Bank accounts in Bangalore, Delhi, Tiruvalam/ Tenpalli offices in Vellore District, in Tamil Nadu to recover our amount. We are ready and willing to bear all necessary expenses for sending the information under the Act.


