Query at Point- 4:

As per Electricity Act 2003 for Central Transmission Utility, prior consent of the landowner is not required. However, notice will be served to the landowners for damages (Crop and tree) likely to be occurred during foundation including earthing, erection and stringing works. POWERGRID has not encroached the applicant land, Counter poised earthing one out of four legs only falls in the applicant's land. Since no crop is found in his land, soil for about 1m depth excavated and backfilled after installation of earthing to protect the tower against lighting.

Query at Point- 5:

It is to mention here that there will not be permanent loss of income to the applicant due to laying of transmission line over applicant's land. All types of agricultural crops/trees can be grown or activities can be taken up after installation of tower/line over the petitioner's land except high growth trees. In the applicant's land bearing Sf.no.213/1, 24nos of coconut trees, 1 no Teak tree are coming in the subject line corridor and the same were enumerated jointly with applicant's authorised representative and notice was issued by notifying the trees in Notice no.196 dated.01.01.2020(copy enclosed) in consultation with applicant "L'" Mr.Ramaraj over phone. The compensation value assessment of the trees is lying with Agriculture/Forest department and it is under process. After receiving the valuation from the concerned authorities, the compensation amount will be informed to the applicant before cutting/removing of trees and will be disbursed to the account of applicant after receiving the ownership documents and after cutting of the trees. The cut trees will be handed over to applicant.

Compensation towards Crop damages if any during stringing (Which is to be taken up in the applicant's land) will be paid by measuring the damages and quantifying in Crop compensation certificate and it will be issued during stringing works.

Moreover, Compensation towards diminution of land value in the width of Right of Way due to laying of our transmission line will be paid as per the G.O.(Ms).63 dated.22.11.2017 and G.O.(Ms).86 dated.30.10.2019 of Energy(A1) department, Tamilnadu as per the Orders of District Collector, Salem. Revenue survey in his land is completed and Collector orders are awaited.
