01	For 400kv dc power line passing from pugalur to Thiruvallam substation as per the technical specification how many type of tower is there based on tower base area length width and height.	The information sought is technical documents and need not be shared and the same is confirmed by Hon'ble High Court of Madras and Hon'ble Supreme Court of India.
02	How much compensation provided to land owners for tower installation please mentioned the amount in Rupees for each type of tower	Petitioner land is not coming in the corridor or tower base. Compensation is being paid as per existing norms in vogue.
03	Is tower installation compensation varied depends on land value from place to place or its fixed amount for all places.	Land compensation towards tower base and line corridor shall be paid as per the Orders of the District Collector concerned in reference to the Tamil Nadu GO Ms No.86 dated 30/10/2019 to the affected land owners.
04	If suppose tower installation compensation depends on land value means how much percentage compensation shall be paid for land owners from land value for each type of tower.	
05	In my village areas one-acre land value is equal to five lakh rupees in this condition 4 to 5 cent occupied tower how much compensation will be paid to land owner.	
06	The power lines which is passing through ground nut crop farming the land farmer doing agriculture activity two times per year the land value is five lakh rupees per acre as per government records in this condition how much compensation will be paid per meter of cable.	Compensation towards the damages caused to the standing crops/trees during the construction activity is paid to the affected land owners as per the assessment of the concerned State Departments viz. Horticulture/Agriculture/Forest.
07	Tower and power line which is installed center of the land but during installation time vehicles like lorry truck, Jeb etc. should be passing through the fence so will they provide the compensation for damages of the fence.	The compensation will be paid for the fencing also if it is damaged during work.
08	26 cable passing from one tower to another tower the cable is passing through ground nut crop agricultural land area. After complete the commissioning work is farmer able to do same agricultural work in under the power line is it safe or not.	Farmer can do agriculture work under the line and it is very much safe. All crops/fruit bearing trees of short height can be grown subject to the required height and electrical clearance as per the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010.
09	Under 26 power cable passing area small agricultural even like groundnut crop also not safe means maximum how much width of the land need to avoid from cable on both sides.	
10	Foundation installation cable laying commissioning activities in the above activities in how many stages compensation will be paid to the land owners.	Compensation to the affected land owners will be paid as per the assessment of the concerned State Departments viz. Horticulture/Agriculture/Forest in line with the actual damage to the crops.
