



**Annexure-II**

**SPECIAL TERMS & CONDITIONS**

1. **Methodology** : Rebound Hammer Test and UPV (Ultra Pulse Velocity) test shall be conducted by College of Engineering, Guindy on the Chimney and Pedestal Concrete for all the tower locations as per the Bill of Quantities in order to ascertain the require strength of the concrete. If the concrete strength found to be lower than the design value, Core sample will be extracted and will be tested in the laboratory. Based on the strength of the above test, the suitability of the foundation will be examined and suitable strengthening methods will be suggested.
2. **Payment Terms** :
  - (i) 25% of the total consultancy charges plus 12.36% service tax shall be paid before commencement of the work along with work order.
  - (ii) On completion of NDT for first half of consultancy work, 25% of the amount plus 12.36% service tax shall be paid.
  - (iii) 25% of the total consultancy charges plus 12.36% service tax shall be paid after submitting the draft report.
  - (iv) Remaining 25% of the total consultancy charges plus 12.36% service tax shall be paid before submitting the final report.
  - (v) Total payment shall be restricted to actual no. of locations where the testing has been Carried out..
3. **Time Period** :

The entire work shall be carried out within 2-3 months from the date of receipt of initial payment (i.e 25 % of total contract price plus 12.36% service tax) .
4. **Other Conditions** :
  - (i) Necessary supporting staff members, excavating equipment with man-power, cleaning of surfaces, power supply, water arrangement etc., are to be provided by POWERGRID for conducting the tests.
  - (ii) Core sample extraction shall be done by POWERGRID and submitted to College of Engineering, Guindy for testing at their lab.
  - (iii) Preparation and testing charges for 300 Core Samples(100 legs x 3 samples) for the consultancy works are included in the Contract price. Charges for each additional sample (i.e 3 cores per sample) (if required) are payable as extra charges @ Rs.2500/- plus 12.36% service Tax.
  - (iv) Based on the results, the suitable rehabilitation measures shall l be proposed by College of Engineering, Guindy, Chennai.
  - (v) Tower Safety has to be ensured by POWERGRID during the testing period.
  - (vi) The boarding and lodging charges including local conveyance for site work shall be borne by POWERGRID.
  - (vii) Tower locations where the testing has to be carried out shall be decided as per the instruction of Engineer-in-Charge
