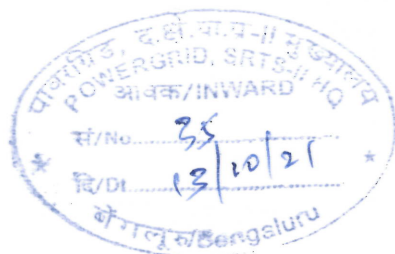
1. I have Planted trees in my formland. The DC line crosses my farm.

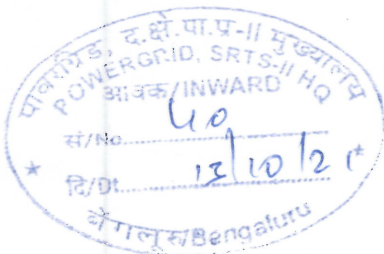
