ORDER

Grounds of Appeal:

Being aggrieved by the information provided by the CPIO, POWERGRID, SR-II, Bangalore, vide his letter No.SR-II:RTI-F-1312/21-22/3289 Dt: 02.02.2022 against the Request of the Appellant vide application dated 03.01.2022, the Appellant has filed this on the following grounds:-

The Appellant has stated that the CPIO Office had not furnished any information which has been requested by the applicant with respect to the application dated 03-01-2022 given and refusing without any reasonable cause.

The Appeal U/S 19 of RTI Act, 2005 Dt. 28.03.2022, received in this office on 30.03.2022. Upon receipt of the said Appeal, CPIO, POWERGRID, SR-II, Bangalore was called and the grievance made in the Appeal was explained to him. He furnished that the RTI request was replied vide letter No. SR-II:RTI-F-1312/21-22/3289 Dt: 02.02.2022.

It is observed that the CPIO has replied all queries as sought in the application and provided within the time limit stipulated in the RTI Act,2005.

Decision:

I have examined the documents connected in the matter and dispose of the Appeal as under:

- a) The Appellant had filed an Application dated 03.01.2022 seeking information in 8 points under the Right to Information Act, 2005 with regard to 400 KV D/C Quad Madhugiri-Yelahanka Line.
- b) The Reply provided to the Appellant vide letter dated 02.02.2022 for points No.1,2,4&5 are/is found to be satisfactory.
- c) Under Point No.6&8 the details sought are of third party information and disclosure of such information as per Clause 8(1) of the RTI Act, 2005 is exempted.
- d) The CPIO is directed to furnish documents pertaining to point No.3 and point No.7 on payment of requisite fees.

With this order, the Appeal stands disposed of.
