**ORDER**

**Grounds of Appeal:**

Being aggrieved by the information provided by the CPIO, POWERGRID, SR-II, Bangalore, vide his letter No.SR-II: RTI-F-1377:22-33/3426 Dt: 02.08.2022 against the Request of the Appellant vide application No. 00234 Dt: 07.07.2022, the Appellant has filed this appeal on the following grounds: -

The Appellant has mentioned that CPIO Office has provided incomplete, misleading or False information with respect to 2 queries in the application dated 07-07-2022, further stating that *"I have requested the information for about 9 items in my RTI, however, I had received the proper response or information for the 7 items only"*.

The Appeal U/S 19 of RTI Act,2005 received in this office on 03.08.2022. Upon receipt of the said Appeal, CPIO, POWERGRID, SR-II, was called and the grievance made in the Appeal was explained to him. He furnished that the RTI request was replied vide letter No.SR-II: RTI-F-1377:22-33/3426 Dt: 02.08.2022.

**Decision:**

I have examined the documents connected in the matter and dispose of the Appeal as under:

- a) The Appellant had filed an application dated 07.07.2022 seeking information on 1-9 queries under the Right to Information Act, 2005. The appellant in this present appeal has stated that he has received proper response or information for only 7 queries, and is seeking proper response for the following 2 queries:
4. *As per Section 2 subsection (f) and section 4 subsection 1 clause (vi), please provide the information related to the compensation paid by Power Grid Corporation of India limited to the land owner for the construction of the Transmission Line Tower including the area of plot, compensation paid & its dates, base for the calculation for the compensation, compensation for the crops & its dates, etc.*
  5. *As per Section 2 subsection (f) and section 4 subsection 1 clause (vi), please provide the information related to the compensation paid by Power Grid Corporation of India limited to the land owner for passing of Transmission Line above the agricultural land including the running length of the Transmission Line compensation paid & its dates, base for the calculation for the compensation, compensation for the crops & its dates, etc.*
- b) Further, the appellant has also raised fresh query in this appeal which cannot be entertained at 1<sup>st</sup> appellate stage.
- c) The Reply provided to the Appellant vide letter dated 02.08.2022 is found to be satisfactory, it is observed that the CPIO has replied all queries as sought in the application and provided applicable and relevant information as per available records and within the time limit stipulated in the RTI Act,2005.

On the above grounds, I do not find any reason to interfere with the RTI reply dated 02.08.2022. Appeal filed by the appellant does not hold good and is liable to be rejected.

With this, the Appeal is disposed of accordingly.
