ORDER

Grounds of Appeal:

Being dissatisfied by the information provided by the CPIO, POWERGRID, SR-II, Bangalore, vide his Letter No.SR-II: RTI:F-1386:22-23/3432 Dt: 08.08.2022 against the Request of the Appellant vide application dated 18.07.2022, the Appellant has filed this on the following grounds:-

The Appellant has stated that the CPIO Office has not furnished the supporting documents to get compensation.

Decision:

I have examined the documents connected in the matter and dispose of the Appeal as under:

- a) The CPIO has replied the queries as sought in the application and provided information within the time limit stipulated in the RTI Act,2005.
- b) Reply to RTI request dt 18.07.2022 was uploaded in the portal, however, the supporting documents was not uploaded due to limitation in file size.

- c) The reply along with the supporting documents was also dispatched by RPAD on 10.08.2022 which has been delivered to the appellant on 13.08.2022.

Since the documents sought have already been received by the appellant, I find no reason to interfere with the RTI reply dated 08.08.2022.

With this order, the Appeal stands disposed of.
