And, if any information or part of it is not available to you then as per Section 6 (3) of RTI Act, you have the power to transfer the application or parts of it, if the same relates to information held by another public authority / PIO concerned immediately and please collect information from the third party if required as per Section 8 - within 5 days - and also inform me about the transfer in writing. Also, provide the information or part of it based on the clause of Severability as per Section 10. As per Section 7 (9), I prefer to receive the information in the same manner as I have asked, in the form of printouts by post as well as via email rsenthilganapathy@gmail.com. And, also mention the name, contact no. and address of Appellate Authority in reply as per Sections 7 and 19 of RTI Act 2005.</p> <p>The information I am seeking is in regard to PowerGrid Corporation of India Limited (Company) and its Transmission line in Pappakudi village, Ariyalur district, Tamilnadu. Therefore, please provide the following information:</p> <ol style="list-style-type: none">1. As per Section 2 subsection (f) please provide the information about the dress code to be followed by the visitors particularly the farmer who visit the PowerGrid Corporation of India Limited office for compensation related things.2. As per Section 2 subsection (f) please provide the information about whether farmers who visit PowerGrid Corporation of India Limited office for compensation issue need to wear pant & shirt or they allowed to wear the Dhoti including Color Dhoti (not lungi).		

3. As per Section 2 subsection (f) please provide the information whether PowerGrid Corporation of India Limited has authority to construct the Transmission tower in the farmer land, while the farmer has filed the case in the Court. Whether PowerGrid Corporation of India Limited can construct tower after the final judgement in the court or clearance of the Judge or during the running of the case.

4. As per Section 2 subsection (f) & Section 4 subsection 1 clause (vi), please provide the information related to the compensation claiming procedure such as the detail of the officers, documents, forms, different approach method etc for the compensation non paid by PowerGrid Corporation of India Limited to the farmer even after 6 years.
