Grounds of Appeal:

Being aggrieved by the information provided by the CPIO, POWERGRID, SR-II, Bangalore, vide his letter No.SR-II:RTI-F-1389:22-33/00253/3450 Dt:24.08.2022 against the Request of the Appellant vide application No. 253 Dt: 25.07.2022, the Appellant has filed this appeal on the following grounds:-

The Appellant has stated that CPIO Office has provided incomplete, misleading or False information with respect to 3 queries in the application dated 25-07-2022, further stating that "incomplete response or no response for 3 queries of my RTI, however, I had received the proper response or information for the other 6 queries".

The Appeal U/S 19 of RTI Act, 2005 received in this office on 29.08.2022. Upon receipt of the said Appeal, CPIO, POWERGRID, SR-II, was called and the grievance made in the Appeal was explained to him. He furnished that the RTI request was replied vide letter No.SR-II:RTI-F-1389:22-33/253/3450 Dt: 24.08.2022.

Observations

The following are observed on examining the "Appeal" & "RTI Application";

1. On perusal of the RTI Application & RTI Reply, it is observed that the applicant Rajamanickam Murugesan has sought for information pertaining to compensation payment issues vide query nos. 1 to 9 of the Application. The CPIO had disposed of the RTI Application on 24.08.2022 furnishing information to the applicant.
2. The Appeal has been preferred by the Appellant on being aggrieved by the reasons that the information provided by POWERGRID is incomplete in some cases and in some there is no

response at all, there was no contact number, email and forms of claim etc., is not mentioned particularly for query Nos. 4, 5 and 7.

ORDER

The Appellant query no.7 is very vague and not specific and RTI Applications should be filed systematically in a structured manner i.e. with specific requests bringing them clearly within the definition of Section 2(f) of the RTI Act, therefore, I do not find any reason to interfere with the RTI Reply in this regard and the appeal does not hold good and is liable to be rejected for query no.7.

CPIO is directed to examine the query Nos. 4 & 5 of RTI Application and give an appropriate reply/information and deal with the same in accordance with the provisions of the "RTI Act".

With this order, the Appeal stands disposed of.
