## ORDER

## **Grounds of Appeal:**

The Appeal U/S 19 of RTI Act, 2005 received in this office on 21.10.2022.Being aggrieved by the information provided by the CPIO, POWERGRID, SR-II, Bangalore, vide his letter No. SR-II: RTI:F-1396:22-23/298/3477 dated 22<sup>nd</sup> September, 2022 against the Request of the Appellant vide application No. PGCIL/R/E/22/298 Dt: 23.08.2022, the Appellant has filed this appeal on the following grounds:-

The Appellant has stated that CPIO has provided incomplete, misleading or False information with respect to 05 queries in the application dated 23-08-2022, further stating that incomplete and vague responses.

## Queries raised:

- 1. Requested for relevet extracts of all discounts/rebates or concessions offered by the empanelled hospitals: Copies of the relevant extracts of the agreement offering the discounts not forwarded. Requested to send photo copies of the relevant page/pages only(1c)
- 2. A vague reply that the discounts/rebates or concessions offered by the empanelled hospitals are being informed to the employees as and when requirement arises.(1d).My request was whether such information has been communicated to the retired employee or not?Answer that as and when requirement arises is a vague reply and does not reply exactly my query.What is as and when requirement arises may be defined?(1d)

- 3. My query that non-communication of such information regarding the discounts/rebates will make retired employees responsible for non-availment of such discounts and the unilateral deduction without such communication is justified or not has not been replied. (1e)
- 4. I have asked the details of deductions made from my claim referred in subject RTI and only lumpsum deduction has been communicated, without item deductions. My request for itemized deductions viz against consultation, pathology charges etc may please be communicated (2)
- 5.My query for specific reply for the applicability of discounts/rebates to procedures like ECG and Echo charges has not been answered as hospital is not allowing the discounts(3)

Upon receipt of the said Appeal, CPIO, POWERGRID, SR-II, was called and the grievance made in the Appeal was explained to CPIO and CPIO furnished that the RTI request was replied vide letter No. SR-II: RTI: F-1396:22-23/298/3477 dated 22<sup>nd</sup> September, 2022 based on the information received from the departments concerned.

I have examined the replies furnished by the CPIO and documents connected in the matter. It appears that appellant is not satisfied with the information provided by the CPIO.

On the above circumstances the CPIO was directed to examine the RTI application and furnish the reply specific to the query raised and deal with the same in accordance with the provisions of the RTI Act. The reply of CPIO is enclosed herewith.

With this the Appeal stands disposed off and a copy of the order may be sent to the appellant.

- f) As a special case, 10% discount IP Billing (excluding Medicine, Consumable, Implants and Blood products) at the hospital rate and 10 % discount on OP consultations and OP Lab and Radiology investigation shall be allowed by the Hospital.
- g) The issuance of a valid Admission slip by Power Grid Corporation of India Limited shall form an irrevocable binding commitment on the part of Power Grid Corporation of India Limited for payment up to the amount committed by it in relation to the services rendered by the Manipal Hospital to the employees under this agreement.
- h) Power Grid Corporation of India Limited shall not withhold any payment of the Manipal Hospital because of existence of any dispute between Power Grid Corporation of India Limited and the employee or the Manipal Hospital and the employee.
- i) In case of delay/ failure of payment within the timelines agreed, Manipal Hospital shall, along with the other rights contained in this agreement, have a right to suspend cashless services, until such time the payments are made.

#### 5. EMERGENCIES:

In case of emergency, IP admission shall be provided by the hospital based on Photo Identity Card thereafter the hospital must intimate to Power Grid Corporation of India Limited, Southern Region Transmission System – II HQ office and the referral letter shall be issued to the hospital within 48 hrs/next working day.

In the event of failure on the part of the employees to furnish referral letter issued by Power Grid Corporation of India Limited within 48 hours, then the Hospital at its sole discretion may extend further medical services on credit basis after obtaining necessary undertaking from the employee or may proceed with the collection of pre deposit as per their normal business practice, which shall be refunded to the employee upon receipt of the necessary authorization from Power Grid Corporation of India Limited subsequently.

#### 6. TERM:

This Tenure of new Agreement is effective from 25.03.2022 to 24.03.2023 (12 months 20 days) and is extendable on mutually agreed terms. The agreement may be terminated by either party by giving minimum notice of one month after settlement of all dues.

The prior termination shall not affect the liability of Power Grid Corporation of India Limited to pay for the service charges in relation to the employees availing the services of Manipal Hospital before receipt of such termination notice. In such an event all the amounts due and payable by Power Grid Corporation of India Limited to Manipal Hospital shall become due and payable at once.
