ORDER

Grounds of Appeal:

The Appeal U/S 19 of RTI Act, 2005 received in this office on 21.10.2022.Being aggrieved by the information provided by the CPIO, POWERGRID, SR-II, Bangalore, vide his letter No. SR-II: RTI:F-1396:22-23/299/3478 dated 22nd September, 2022 against the Request of the Appellant vide application No. PGCIL/R/E/22/299 Dt: 23.08.2022, the Appellant has filed this appeal on the following grounds:-

The Appellant has stated that CPIO has provided incomplete, misleading or False information with respect to 02 queries in the application dated 23-08-2022, further stating that incomplete and vague responses.

Queries raised:

- 1. My query was whether the subject circular referred in my RTI query has been specifically communicated to the retired employees. Just by answering to me it is extended to the retired employees as well does not amount to reply. My query specifically asked whether the subject circular has been communicated to all the retired employees through a public portal so that it will reach the superannuated employees spread across the country(1)
- 2. How the superannuated employees can avail the discounts/rebates with out the same communicated to the retired employees through retirement portal.(2)

Upon receipt of the said Appeal, CPIO, POWERGRID, SR-II, was called and the grievance made in the Appeal was explained to CPIO and CPIO stated that the RTI request was replied vide letter

Upon receipt of the said Appeal, CPIO, POWERGRID, SR-II, was called and the grievance made in the Appeal was explained to CPIO and CPIO stated that the RTI request was replied vide letter No. SR-II: RTI: F-1396:22-23/298/3477 dated 22nd September, 2022 based on the information received from the departments concerned.

I have examined the replies furnished by the CPIO and documents connected in the matter. It appears that appellant is not satisfied with the information provided by the CPIO.

On the above circumstances the CPIO was directed to examine the RTI application and furnish the reply specific to the query raised and deal with the same in accordance with the provisions of the RTI Act. The reply of CPIO is enclosed herewith.

With this the Appeal stands disposed off and a copy of the order may be sent to the appellant.
