Also, provide the information or part of it based on the clause of Severability as per Section 10. As per Section 7 (9), I prefer to receive the information in the same manner as I have asked, in the form of printouts by post as well as via email rsenthilganapathy@gmail.com. And, also mention the name, contact no. and address of Appellate Authority in reply as per Sections 7 and 19 of RTI Act 2005.</p> <p>The information I am seeking is in regard to PowerGrid Corporation of India Limited (Company) and its Transmission line in Pappakudi village, Ariyalur district, Tamilnadu. Therefore, please provide the following information:</p> <ol style="list-style-type: none">1. As per Section 2 subsection (f) please provide the information related to the commissioning date of the tower in Rajamanickam Murugesan land by PowerGrid Corporation of India Limited in the survey number 328 sub section 3A in Pappakudi Village, and the final judgement date for the case related to the land.2. As per Section 2 subsection (f) please provide the information whether PowerGrid Corporation of India Limited constructed the		

tower in Rajamanickam Murugesan land (survey number 328 sub section 3A in Pappakudi Village) after the clearance by the judge or final judgement & confirm the above activity is carried in accordance with law without hindering Indian Citizen rights. Please furnish the court clearance order to construct the tower in the above survey number.

As per Section 2 subsection (f) please provide the information what is the reason no compensation was paid to Rajamanickam Murugesan for the construction of the Tower by PowerGrid corporation of India limited when they had paid to the other land owner for the movement of the vehicle used for the transportation & assistance in the tower construction (adjacent land owner with land survey number 328 & within its sub division).
