Reply for your queries raised are given below.

- Query 1:** 1. Commissioning date of Tower in Sy No.328 sub-section 3A – 19.10.2016
2. Judgement is a public document and it is available in APHC web site.
Resumed works after stay vacate order by HC.

Query 2: As stated in reply to S No 1, Tower foundation in survey no 328/3A was done on 04-09-2016 after receipt of DC, Ariyalur proceeding dt 27-08-2016 to take up Transmission line activities.

The Tower construction started in the land of Rajamanickam Murugesan in survey No.328 sub sec.3A in the village Pappakudi by Power Grid Corporation of India Ltd. immediately after receipt of orders of District Collector, Ariyalur on 27.08.2016 as per Section 16(1) of the Indian Telegraph Act. However, works were suspended in between due to Status Quo orders in WP No.31794/2016 were pronounced by Hon'ble High Court of Madras. Subsequent to stay vacation/disposal of the Writ, works resumed again. The orders pronounced in the said Writ petition is available on the website and can be accessible by the petitioner/s (applicant herein) as it is available in Public domain.

Query 3: It is to state that there were no trees or crops and damages reported in the survey no 328/3A during construction of transmission line. Therefore, compensation payment were not paid.

Query 4: Quality & Financial Audits are carried out periodically as per prevailing laws/Rules/Regulations and specifications, and also no one raised any issue or complaint in this regard.
