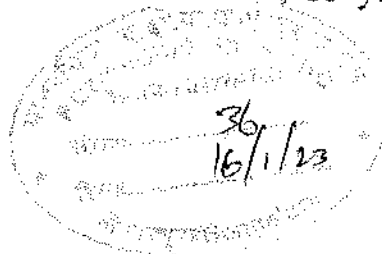

Sub : Petition filed u/s 6 of RTI act of 2005 for obtaining the
following information regarding.

Sir, I am residing in Somanahalli village cum post, Nallampalli Taluk,
Dharmapuri district along with my family, the fact is so, yours formerly officers
had erected the tower of 400 kv electric power and conveying the power cable line
on my agriculture land, so they had provided the scarcity and insufficient relief to
me and destroyed my Horticulture and silviculture. My sons and daughters and
grand children are depending the surviving sources from my said land, meanwhile
you had erected the tower and conveyed the 400 kv cable through in my land, so
we are not able to cultivate any agriculture crops, horticulture and silviculture,
further some other non curable health complaints also caused to the persons
habituating nearby the tower and cable, so you had provided only scarcity of



monetary relief to me and my family, so already you have sent the irrelevant and non formal information given to some other affected tiny farmers.


Further one Sakthi had obtained the relief amount a sum of Rs.20,00,000/- twenty lakhs rupees and another one Seker received the relief amount a sum of Rs.20,00,000/- twenty lakhs rupees, but utilized the land measured about less than our land, both are adjacent land and there is no any maximum loss of tress, agriculture and horticulture to them, but they have only issued the insufficient relief to me compare than said persons.

Further some other land owners are obtained the more excessive relief money compare than me, but such a lands are less amount of measurement compare than me, so your formerly officers had unlawfully and wrongly assessed the valuation and provided the major variation and different among the victim poor farmers, so I need the following information.

1. How many farmers were obtained the relief for erected the tower and conveying the power cable line power about 400 kv in all over Dharmapuri district.
2. Please issue theirs name, extent of land, damaged crops, trees and horticulture and the determination of relief amount to the individual crops, trees, and horticulture.
3. On which basis you have determined the relief to the farmers through the major variation of relief among the victim farmers in Dharmapuri district.

Please send the aforesaid information as earlier as possible to me for our assessment and getting the legal remedy through the court of law. Further India Postal Order for the value of Rs.10 enclosed herewith.
