In exercise of the powers vested with Power Grid Corporation of India Limited (An Enterprise of the Govt. of India Ministry of Energy, Department of Power) under Indian Telegraph Act 1885, para III, section 10 to 19 conferred under section 164 of the Electricity Act 2003 through the Gazette by India, Extra Ordinary dated 24<sup>th</sup> December 2003, notice hereby given that 400 kV Electric Transmission Line from MYSORE to KOZHICODE will go through your property and under. While due care will be taken to minimize the damages to standing trees and crops, certain minimum unavoidable damage is likely to take place during construction / erection of the aforesaid line.
