Provided Incomplete, Misleading or False Information vide WRTS-I/PMS/340/2740 dated 03.12.2018 by PIO, POWERGRID, Western Region-I, Nagpur, against the Request of the Appellant dated 09.11.2018, the Appellant has filed the following:-

After receipt of appeal dated 03.12.2018 PIO has been called and made aware of the queries in the appeal.
