
Subject - Information under the RTI Act, 2005

This has reference to your RTI Application No.: **PGCIL/R/E/21/00036 dated: 17.01.2021** received on 17.01.2021 under the Right to Information Act, 2005.

RTI Request		Respected Prime Minister Sir,
	8.	I am a resident of Seoni district and I have previously worked as a labourer at the Government of India Company Power Grid Corporation of India Limited, whose sub-station is in Lugharwada, Seoni. I have some questions, which are as follows 1. The time of permanent staff working at Powergrid Substation, Lugharwada, Seoni is from 9 am to 5:30 pm, where lunch hour is from 1 pm to 1:30 pm (half an hour). But some employees present in Seoni, punch at 9 am in the morning and go come and come back to office comfortably at 10 am, after threat the employees here have lunch from 1 pm to 4 pm (3 hours), which is against the rules & regulations of Government of India company Power Grid Corporation of India Limited. Permanent employees working in Powergrid Substation, Lugharwada, Seoni are paid a hefty amount of salary, even after that there is so much slackness in work by employees, which is a huge loss for the company. Therefore, I request the Government of India to regularly monitor the work of the employees present at Powergrid Substation, Lugharwada, Seoni.
		2. Apart from this, there is a Guest House present at Powergrid Substation, Lugharwad, Seoni. The maintenance of which has been given to the private agency M/s Animesh on contract, which costs Rs. 80000 to 90000 every month, where hardly 2 to 3 guests come every month, which is wastage of public money. It is also hub for making parties by employees during office hour. I want to know that why company is unnecessarily wasting so much public money every month fot the stay of only 2 to 3 guests. I would request authorities to kindly close such Guest houses & save public money wastage.
		Power Grid Corporation of India Limited has been set up utilizing public money, to serve public & not for enjoyment of employees. Therefore, I request to the Prime Minister as a common citizen to take proper action on such employees & companies.
