This has reference to Your RTI online application having RTI Registration Number: **PGCIL/R/E/21/00186 dated. 24.04.2021**. The information required by you under RTI Act 2005 is as under:

Information Sought	:	I am a POWERGRID employee (emp.no. 60021013). My Medical claim for Non-Hospitalization with ESS Request ID 6002101300031 has been rejected by the concerned authority citing is of my spouse who is a State Government Employee posted in Bihar. However, I have given the applicable declaration to show her as dependent for medical benefits. IN THIS CONTEXT:
	1.	Is it required to obtain outstation treatment approval (Non-Hospitalization and/or Hospitalization) for availing medical benefits for my wife if she avails of medical treatment at places other than that of my place of posting?
	2.	Is it required to accompany my wife i.e., be on leave for availing medical benefits for my wife if she avails of medical treatment at places other than that of my place of posting?
Reply 1	:	As per procedure if Dependent is Employed, then Employee has to provide Employment details of the Dependent and declare confirmation that the Dependent (Wife in this case) is not availing any medical facility from her employer. In case the same is not submitted to POWERGRID, the same may be submitted on priority, refer POWERGRID letter ref. no. WR-I:RHQ:HR:Estt:2021: dated 18.05.2021 for which your reply is awaited till date.
Reply 2	:	If permission is obtained for family retention at place other than place of posting, it is not required for employee to be on leave.

The first appeal, if any, against the reply of PIO may be made to the first appellate authority within 30 days of receipt of reply of PIO.
