विषय:- सूचना के अधिकार अधिनियम 2005 के अंतर्गत आवश्यक जानकारी ।

This has reference to Your RTI online application having RTI Registration Number: PGCIL/R/E/22/00082 dated. 04.03.2022.

"It is bring to your kind notice that the RTI Act 2005, confers on the citizen the right to information only, and not the explanations, reasoning and justification of the information. The Public Information Authorities cannot expect to communicate to the citizen the reason why a certain thing was done or not done in the sense of a justification because the citizen makes a requisition about information. Justifications are matter within the domain of adjudicating authorities and cannot properly be classified as information.

Information has been defined by Section 2(f) as follows.

Section 2(f) - Information means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force; Thus, the definition does not include within its fold answers to the question why which would be the same thing as asking the reason for a justification for a particular thing. "

The information sought by you is as under:

1	Information Sought	: POWERGRID Company established the tower line Aurangabad to Mumbai in Maharashtra. I requested to give me the information about the tree cutting process under the tower line and when I request to company officers for cutting the plant in my farm then what is the process? Give me information please.
	Reply	: During patrolling/maintenance of transmission line, trees falling under transmission line corridor are periodically pruned and felled by POWERGRID to avoid its regeneration and un interrupted. However, as per Electricity act 2003 - Part - VIII Overhead lines clause - section 68 clause -5 and Telegraph act 1885 Part - III clause - 18 (1) & (2). "The trees planted near tower and below the conductor/line corridor after charging/commissioning of transmission line shall not be liable for compensation against their regeneration and growing".




