Justifications are matter within the domain of adjudicating authorities and cannot properly be classified as information.*

**Information has been defined by Section 2(f) as follows.**

**Section 2(f) – Information means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports ,papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force;**


