

This has reference to Your RTI online application having RTI Registration Number PGCIL/R/E/23/00471 dtd 04.12.2023

"It is bring to your kind notice that the RTI Act 2005, confers on the citizen the right to information only, and not the explanations, reasoning and justification of the information. The Public Information Authorities cannot expect to communicate to the citizen the reason why a certain thing was done or not done in the sense of a justification because the citizen makes a requisition about information. Justifications are matter within the domain of adjudicating authorities and cannot properly be classified as information.

Information has been defined by Section 2(f) as follows.

Section 2(f) - Information means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force; Thus, the definition does not include within its fold answers to the question why which would be the same thing as asking the reason for a justification for a particular thing. "

WRPC certifies the monthly availability of the total POWERGRID transmission system in Western Region that includes total transmission system of WR-I and WR- II. There is no separate provision for availability certification for every substation like Solapur. WRPC certifies only monthly availability and there is no provision for Annual availability.


