The line is constructed as per the technical suitability considering various techno economical aspects. The approved map is the Copy right property and can not be provided. However this is to submit that route details of line were already intimated through news papers etc during construction and before charging as per annexure enclosed.

3) *For construction of this line approximately compensation of Rs 24,08, 27075.00 have been disbursed in about 8752 cases. The individual details of beneficiaries can not be divulged ..*
