महोदय,

This has reference to your letter No.103 dated 19.09.2019 received in this office on 24.09.2019. The applicant has sought for the information pertaining to 7/12 extracts of the land details, compensation details etc., of the affected land lords of various Transmission Lines passing through the Districts of Boisar, Aurangabad, Navsari & Pune as in the capacity of President, Nirbal Indian Shoshit Hamara Aam Dal, Nishad Party Dhule.

The Application seeking information as above has been rejected in the following grounds;

- 1. The information sought as above purely relates to the personal information of farmers such as 7/12 extracts of the land & extend of the land affected due to drawal of various transmission lines in different districts of Maharashtra, notices issued to them, compensation details such as amount and payment details and the disclosure of the same has no relationship with any public interest would cause unwarranted invasion of the privacy of the individual. Further, the applicant had not established any bona fide public interest in having access to the information sought nor did he has any association or business relationship with the land owners. Hence, the disclosure of the same cannot be acceded to, as the same is exempted under section 8(1)(j) of RTI Act.
- 2. Further, the applicant had filed the subject application for the information asking for "all the records" regarding the information pertaining to 7/12 extracts of the land details, compensation details etc., of the affected land lords of various Transmission Lines passing through the Districts of Boisar, Aurangabad, Navsari & Pune as in the capacity of President, Nirbal Indian Shoshit Hamara Aam Dal, Nishad Party Dhule, which amount to a sort of frivolous application, making a mockery of the Act.
- 3. The details of the information sought as above are pertaining to the amount of compensation assessed & approved to various Landlords through which the transmission line passing over, which are purely Information pertaining third parties and are also relating to the personal information of others and the disclosure of which would cause unwarranted invasion of the privacy of the individuals and hence exempted from disclosure under section 8(1)(j) & 11 of RTI Act.
