On the subject cited above , it is to inform that 220KW Electric line was laid in the year 2010 by Power Grid Corporation of India Ltd, Ambheti in village Sayli of Dadra and Nagar Haveli. The said High Tension line has been passed through my land by erecting one tower in land bearing Survey No. 104/1 of village Saily. I am the owner of the said land. In this regard, it is came into the notice that the compensation an amount of Rs.1,71,200/- (credited on 11/05/2010) was made to any other person namely- Shri Bhikhubhai Dahyabhai Rathod in his Saving Bank Account No. 10291105733 of State Bank of Silvassa Branch. In fact, this compensation should have to be deposited to my account(Prabhatsinh Dahyabhai Parmar's account) or in case of cheque payment , it should have to be in my favour. Accordingly, I have not received any payment towards the compensation.

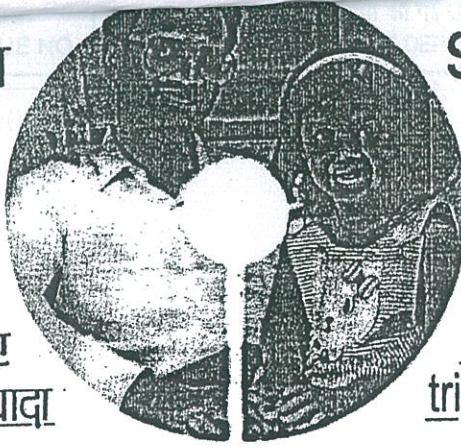
