

- (i) Copy of documents i.e 7x12 form & Form No. 6 (land revenue records) obtained by the Power Grid Corporation of India, Ambheti either from the land owners or from the Govt. Office nearby land bearing survey No.104/1 of village Saily,DNH (from Sl. No 1 to 10 as appeared in the provided list vide your letter dated 11/02/2020, copy enclosed) which is affected by laying 220 KV line to verify the ownership of the affected land for the purpose of payment of compensation through which 220 KV line was laid.
- (ii) All filled up forms available with the Power Grid, Ambheti (including First form filled by the officer/staff of Power Grid ,Ambheti) related to land bearing Survey No.104 (i.e. Survey No. 104/1) of village Saily, DNH which was shown to me by Shri Sunil Patel and Shri Kishankumar of Power Grid, Ambheti during my visit to Power Grid Corporation of India, Ambheti on 18/01/2020 between 11.15 am to 12.45 pm.
